



# POTENTIAL COOPERATION WITH BPKH

Badan Pengelola Keuangan Haji (BPKH) is the Indonesian (Sovereign) Hajj Fund Management Agency set up pursuant to the Law No. 34/2014 on the Management of Indonesian Hajj Fund. Established in 2017, the basis of its establishment and operation are provided in the Presidential Decree No. 110/2017 and the Government Regulations No. 5/2018 respectively. It is mandated by law to manage and invest the fund entrusted by the pilgrims in Shariah compliant portfolios to optimise the return and distribute the profits in the manner stipulated therein. As of today, the fund size has increased to over Rp 136 trillion (US\$8.77billion) and it will continue to increase as more and more Indonesians register to go for pilgrimage.

For BPKH, the years 2020 - 2022 are the years of direct investment. In order to ensure effectiveness and focus, now we have Foreign Investment and International Relations Department as the dedicated department focusing on BPKH investment abroad.



**PORTFOLIO** The Foreign Investment and International Relations Department consists of three divisions namely: Foreign Investment, International Relations and Advisory and Support Abroad. With respect to foreign investment, while hajj related business/activities are of particular interest to us, we can invest in various Shariah compliant business, assets and/or instruments abroad. For instance: we can set up companies, invest in business, equities, joint venture, buy assets/properties, invest in funds, trusts, etc. We can provide financing and can enter into club or syndicated deals. We can invest in any banking products other than saving accounts, we can invest in capital as well as money markets, services business and any other Shariah compliant transactions and/or commercial activities. We welcome cooperation with foreign based entities in matters of mutual interest and we provide advisory services too (eg, transaction structuring, feasibility studies, set up hajj management fund, etc).
